In order to operate effectively, we have established sustainability commitments which consist areas where we have material influence:

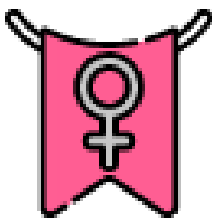
Our Commitments

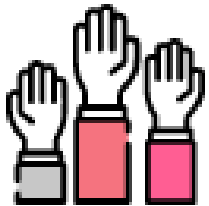
Check Point understands the impact it has on the **environment** and places a strong emphasis on achieving a more sustainable world by proactive initiatives and innovation:
