

With this deployment approach organizations no longer need to wait for users' actions and can quickly activate the protection on devices using the MDM/UEM integration. If the app is not installed, the device is blocked from corporate resources using automatic compliance rules and actions configured in 7P-EMM. Users can receive a 7P-EMM notification and clicking it will automatically deploy the Harmony Mobile app from 7P-EMM. You can also periodically check and enforce device updates with 7P-EMM and update the Harmony Mobile app on devices accordingly.

Mitigate and eliminate threats right on the device

When a threat is identified, Harmony Mobile automatically mitigates any risk until the threat is eliminated. Integration with your 7P-EMM allows the solution to restrict secure container access, or make real-time, risk-based policy adjustments on compromised devices. Harmony Mobile also activates an on-demand VPN to tunnel data traffic away from cybercriminals and to avoid data exfiltration while keeping users connected.

Automated Device Management

Automatically protect new devices as soon as they are enrolled in 7P-EMM. Devices are also automatically deleted from Harmony Mobile once they have been removed or retired within 7P-EMM.
