## WHAT ARE CYBER SECURITY LEARNING CREDITS (CLC)?

Check Point CLCs enable customers to purchase training when buying new software, appliances, support, and services. Investing in learning credits ensures that customers receive the highest quality of training through innovative Check Point Cyber Security Training Programs led by Check Point Authorized Training Center (ATC) partners and other world-class professionals. Each Learning Credit (CLC) is valued at \$100 (USD) and is valid for one year from the date it is activated.

The ability to get the most of your Check Point Cyber Security investments and meet your business goals is directly tied to the skills and expertise of your IT staff. With the right training, your organization will retain a competitive edge and remain ahead of the technology curve. This enables you to increase productivity and safeguard your training budget by addressing your training needs at the time of the product purchase.

## HOW MANY LEARNING CREDITS SHOULD I BUY?

Check Point recommends that you include a 7%-10% training budget for every deal in order to optimize your cyber security investment. As an example, if the deal is valued at \$100K, we advised you to add 70-100 CLC units to your quote. CLC subscription packages yield the highest optimal value.
